PLC Files suit over BLM Public Lands Rule

In mid-July, national PLC and a coalition of ag and natural resource groups filed its case in the U.S. District Court for Wyoming challenging the Biden Administration's Bureau of Land Management (BLM) Conservation and Landscape Health rule. The final rule has caused significant concern for grazers and other partner groups, because the rule upends multiple-use management, circumvents public processes, and could facilitate the reduction of grazing. PLC has led industry engagement in each step of the process and upon review of the final rule, core concerns remained which led to this filing.

The suit challenges the rule on three fronts:

- The rule exceeds BLM's statutory authority in creating uses, leasing systems, and multiple-use prioritizations, and the authority to withdraw lands without public input or Congressional approval.
- The rule is arbitrary and capricious.
- The rule violates the National Environmental Policy Act.

PLC will keep its affiliates apprised of the developing lawsuit as it moves through the legal system processes.

Gunnison Sage Grouse Planning Update

The Bureau of Land Management is in the protest period for the Gunnison Sage-Grouse proposed Resource Management Plan Amendment and Final Environmental Impact Statement. The proposed RMP Amendment/Final EIS was published on July 5th and CO PLC has 30 days to submit a valid protest. CO PLC commented on the draft management plan to ensure flexible and adaptive management strategies that allow for continued grazing while protecting the Gunnison Sage Grouse habitat.
